The relevance of the Companies Act to the economy of the country cannot be over-emphasized, as overwhelming part of economic activity is carried through corporate structure, and the Act, being the principal law affecting the working and operations of companies, has a direct bearing on the corporate sector. In light of this, the passing of the Companies Act, 2013 was a landmark development for the corporate sector.

Companies Act, 2013 has undergone rigorous review process. Firstly, by the Company Law Committee constituted by MCA to recommend necessary changes to the Act for its proper and effective implementation which came out with its report, being 164<sup>th</sup> Company Law Committee Report in February, 2016. Companies (Amendment) Bill, 2016 that was introduced in Lok Sabha was again referred to the Standing Committee on Finance on April 12, 2016 for its examination and report thereon. Companies (Amendment) Bill, 2017 passed by both the houses captured the amendments proposed by both the parliamentary committee.

MCA has now implemented majority of the provisions till date. Critical amendments that will have an impact on compliance requirements viz. amendments to Section 42, 89, 90, 188, 197 are yet to be enforced. The Lecture meeting is being organized to discuss on the enforced provisions, immediate actionables and practical difficulties likely to be faced by the companies.
