Dear Sir,

1. I/We, the bidder/s do hereby state that I/We are submitting the bid in the e-auction, on my/our own account/on behalf of another person/s/consortium, the details of which/whom have been furnished in the EOI. In case I/We am/are submitting the bid on behalf of any person/s/consortium, I/We have the requisite authority which has been duly intimated in writing to the Liquidator. Also, my/our declaration as this shall be deemed to be the declaration of such person/s/each member of the consortium who has authorized me/us to submit the bid.
2. I/We, the bidder/s do hereby state that, I/We have read the entire Invitation dated 10.01.2018 (“Invitation”) and have understood the terms and conditions fully. I/We understand that the terms and conditions as stated in the Invitation stand incorporated herein. I/We, hereby unconditionally agree to abide with and to be bound by the said Invitation and agree to take part in the e-auction, in my/our own discretion.
3. I/We do hereby affirm that I have read the terms and conditions of the Invitation, and I have agreed to participate in the auction on my sole discretion and for my own benefit. I/We have further given an undertaking dated \_\_\_\_\_ in respect of my/our participation in the sale process, and the same shall stand incorporated herein by reference.
4. I/We have received and read the Information Sheet in entirety, and understand that bid is being submitted by me/us independently, after carrying out requisite due diligence and after being satisfied in all respects as to the Property. I/We declare that I/We shall not claim excuse of non-availability/non-receipt of any information/document from the Liquidator/Seller, after submission of the bid.
5. I/We declare that the EMD and other deposit towards purchase consideration were made by me/us as against my/our offer and that the particulars of remittance given by me/us in

the bid form are true and correct.

6. I/We further declare that the information revealed by me/us in the EOI document is true and correct to the best of my/our belief. I/We understand and agree that if any of the statement/information revealed by me/us is found to be incorrect and/or untrue, the offer/bid submitted by me/us is liable to be cancelled and in such case, the EMD paid by me/us is liable to be forfeited by the Liquidator and that the Liquidator will be at liberty to annul the offer made to me/us at any point of time.
7. I/We understand that in the event of me/us being declared as successful bidder by the Liquidator, I/We are unconditionally bound to comply with the terms and conditions of sale. I/We also agree that if my/our bid for purchase of the asset/s is accepted by the Liquidator and thereafter if I/We fail to comply or act upon the terms and conditions of the sale or am/are not able to complete the transaction within the time limit specified for any reason whatsoever and/or fail to fulfill any/all of the terms and conditions, the EMD and any other monies paid by me/us along with the bid and thereafter, is/are liable to be forfeited by the Liquidator and I/We hereby consent to the same.
8. I/We also agree that in the eventuality of forfeiture of the amount by the Liquidator, the defaulting bidder shall neither have claim on the Sale Asset or the Liquidator nor on any part of the sum for which it may be subsequently sold.
9. I/We also understand that the EMD of top 2 (Two) offerors/ bidders shall be retained by the Liquidator and returned only in accordance with the terms of the Invitation.
10. I/ We shall observe due care while putting our bids in the auction process, without entering into any collusion, understanding or arrangement with any person, and allow smooth and transparent discovery of the price of the Sale Asset.
11. I/ We agree not to hold the Liquidator or the E-auction Service Provider, responsible for any *bonafide* technical failures in the auction process or technology platform, causing any delay, deferment, cancellation, re-fixation of the auction time or date.
12. I/We understand that the e-auction being organized by the Liquidator, is for the purpose of price discovery for the intended sale of the Sale Asset, which, based on the price so discovered, is intended to be sold/transferred by way of a further agreement for sale, and a sale certificate, in the manner as provided by applicable law;
13. I/We confirm that I/We have gone through the draft agreement for sale/draft conveyance shared by the Liquidator, and I/We shall not insist on any change/modification/amendment

in the said draft agreement/draft conveyance, except to the extent of supplying necessary facts for execution of such agreement/certificate.

14. I/We understand that the conclusion of the auction does not amount to an assurance on the part of the E-Auction Service Provider or the Liquidator as to conclusion of the sale, or any other assurance at all. The successful conclusion of the auction does not, by itself, result into any rights on the part of the bidder against the E-Auction Service Provider or the Liquidator in any manner.
15. I/We agree that the Liquidator is not nor shall be in any manner responsible for any delay, suspension, deferment, or cancellation of the auction or the subsequent sale of the Sale Asset for any reason whatsoever, including but not limited to any legal proceeding, order or direction of any authority, or any other reasons.
16. I/We understand that the sale of the Sale Asset is intended to take place in accordance with applicable law, including the Insolvency and Bankruptcy Code, 2016, and in accordance with the terms and conditions contained in EOI, invitation and other bid documents or in the agreement for sale to be executed between the Liquidator and the successful bidder, on payment of the full consideration as provided in the Invitation.
