Richard Branson's new luxe cruise line won't allow kids

Richard Branson's Virgin brand launched an adults-only cruise ship arm that opens in April — just as the fast-growing sector suffers its most serious setback in years from the coronavirus outbreak.

Scarlet Lady, unveiled in Dover, England, on Friday and the first of four new vessels that will form the Virgin Voyages fleet, aims to bring "the luxe experience of a boutique hotel to the sea," the bil-

lionaire said in a statement.

While the ship will be based in Miami for voyages in the Caribbean, thousands of miles from the Asian epicenter of the virus, it's not clear what impact the epidemic will have on wider demand.

The ordeal of 3,700 people held on board a vessel in Japan as disease spread among passengers has made headlines around the world, while Carnival Corp. and

Royal Caribbean Cruises Ltd. have issued profit warnings. Virgin's fleet will aim to capitalize on a boom in cruising among younger people.

Ships will boast interiors by Tom Dixon and Roman and Williams and offer gym programs, yoga, 20 restaurants featuring Michelin-standard food and entertainment including drag acts and sets by star DJs including Mark Ronson.

Daimler AG warned of a further crackdown on Mercedes-Benz diesel vehicles in Germany and boosted provisions for legal and regulatory costs that already crimped profit last year.

The country's motor industry watchdog, KBA, is likely to rule that other vehicles made by the luxury brand were also "equipped with impermissible defeat devices," Daimler said Friday in its annual report, referring to banned software designed to bypass emissions tests.

Daimler has temporarily halted delivery and registration of some models, according to the report. It boosted total provisions to 30.7 billion euros (\$33.2 billion) from 23 billion euros, with potential liability and regulatory costs more than doubling to 4.9 billion euros. The shares fell as much as 2.3% in Frankfurt trading. The German manufacturer also said complying with stricter emissions rules in some countries will be difficult.

The carmaker's move indicates trouble ahead for its diesel cars. Daimler took a massive earnings hit in 2019 and slashed its payout to investors to the lowest level since the financial crisis, blaming an 870 million euro fine by German prosecutors and costs related to reducing diesel-car emissions.
