Cadila-CSIR's sepsis drug shows promise in fight against Covid-19

The drug is all set to go to phase 3 of clinical trials after the earlier phase showed positive results

Mumbai, 22 June

s the race to find treatment or vaccine for Covid-19 hots up, Ahmedabad-based Pharmaceuticals and the Council of Scientific and Industrial Research's (CSIR's) Sepsivac is all set to enter Phase 3 clinical trials after the earlier phase showed positive results.

The public-private partnership trialgenerated data will be soon presented before the country's drug regulator to see if it can get emergency-use autho-

"By July 15, we will have the necessary data from the Phase 2 trials and again approach the regulator to see if this drug can be given emergency-use authorisation in the wake of the pandemic. Meanwhile, we also have the approval in place to start two Phase 3 trials — one on 600 patients, another on 500 patients — for this drug," said Ram A Vishwakarma, director, CSIR-Indian Institute of Integrative Medicine.

The Phase 2 trials were conducted across Postgraduate Institute of Chandigarh, All India Institute of Medical Sciences (AIIMS) Delhi, and two more sites will be added — AIIMS

Vishwakarma explained that Sepsivac is an immunomodulator Sepsivac is not an antibody-generating vaccine. "It can be called a therainnate immunity. There are two kinds inflammatory Cytokine IL-6 that get from our ancestors and there is the

acquired immunity. Acquired immunity is mostly governed by antibodies," said Vishwakarma

Whenever a virus or bacteria attacks our body, the innate immunity or trained immunity first reacts. "We are boosting this trained immunity or what we call scientifically, Th1 (T helper type 1). It reacts in most patients, which is why they get cured. In some with comorbidities, their immune system is compromised." already Vishwakarma.

Given in the early phase of infection, it protects the patient from infection. The second way in which this drug works is by inhibiting the IL-6 or inflammatory cytokine.

'Most of the damage happens due to this in IL-6 in patients. A Roche drug Tocilizumab works in this manner. Sepsivac or Mycobaterium w also stops the release of IL-6 which would control the multi-organ damage. A patient's innate immunity then has an opportunity to protect him," he explained. Mycobaterium w is not a SARS-CoV-2 (severe acute respiratory syndrome-coronavirus-2) virusspecific immunity.

Further, in the Phase 3 trial, the plan is to give the drug to a group of 500 natients after they have recovered from the virus, so that they do not redevelop

54 employees test +ve, ONGC haltsopsat2rigs

New Delhi, 22 June

State-run Oil and Natural Gas Corporation (ONGC) has halted operations at two drilling rigs in Western Coast, following the death of an employee and another 54 testing positive for coronavirus (Covid-19). The two rigs are in two of the most lucrative assets of the company — Mumbai High and

A company official said work stopped temporarily only at two rigs and the remaining 34 in the offshore were operational. He added there was no impact on the firm's production. Mumbai High, also known as Bombay

High, is an offshore oilfield located in the Arabian Sea, approximately 160 km west of the Mumbai coast. The field, discovered in 1974 and started production in 1976, is known primarily for its oil production. It also consists of two blocks -Mumbai High North and Mumbai High South. Mumbai High produces around 170,000 barrels of oil per day and 12 million metric standard cubic metres per day (mmscmd) of natural gas.


On the other hand, Bassein field, also called the Vasai field, is located 80 km off the Mumbai coast and is considered one of the largest gas fields in India. The field was discovered in 1976 and put in production in 1988. Spread across 7,300 square kilometres in the Arabian Sea, it consists of South Bassein field, NBP (D-1) field, B-193 super sour field, Vasai East field and C-Series and Daman gas field.

ONGC claimed that works are going on following the standard operating procedure and its staff is properly informed about social distancing. Interestingly, ONGC employee bodies had reportedly alleged that the infection was spreading due to lack of proper guidelines. During the lockdown, its staff in Mumbai offshore fields were working continuously for five weeks. It was only after the lockdown restrictions were lifted did ONGC arrange for charter flights for their workers to reach Mumbai.

The company's overall production was hit badly by the lockdown due to the Covid 19 outbreak. In April, the company's natural gas production dropped by 15 per cent while its crude oil production dipped marginally by 0.5 per cent compared to the same month in 2019.

Overall, gas output of India for April also dropped 18.6 per cent to 2.16 billion cubic metres (bcm) against 2.65 bcm a year ago. Crude oil production also fell 6.35 per cent to 2.5 million tonnes (mt) in April.

The state-run major cut its capital expenditure (capex) by over 15 per cent or ₹5,000 crore for 2020-21. India's largest oil and gas producer had budgeted a capex of ₹32,502 crore for the financial year.
