The matter is taken up on VC.

IA No. 961/2021

Mr. Vinod Kothari, Liquidator of the Corporate Debtor (the Applicant) is present. This is an Application filed by the Liquidator for the extension of the Liquidation period. It is submitted that previously the Liquidation period was extended by order of this Bench dated 27.01.2021 by three months i.e. till 26.04.2021.. It is submitted that the Liquidation process is still in progress.

On hearing the Liquidator, we are satisfied that the Liquidation period needs to be extended. We hereby extend the period of Liquidation by six months from today. The Liquidation period will thus come to an end on 06.11.2021. The Liquidator is directed to complete the process within the time granted. Accordingly, Application bearing IA No. 961 of 2021 is allowed and disposed of.
