Dues of Workmen as on 17. 10.2017

1. The classification of employees as “workmen” [as defined in sec. 3(36) of the Insolvency and Bankruptcy Code read with sec. 2(s) of Industrial Disputes Act, 1947] of Nicco Corporation Limited (“**Company**”) has been done by competent retained officials the Company.
2. This document has been divided into two parts:
 - a. Claims received from workmen (**Annexure- 1A) (Annexure 2-A) (Annexure 3-A)**; and
 - b. Claims admitted as per books of the Company distinguishing claims admitted for 24 months preceeding the liquidation commencement date and remaining dues for the prior period. (**Annexure- 1B) (Annexure 2-B) (Annexure 3-B)**
 - c. Annexure 1 pertains to Shyamnagar workmen
 - d. Annexure 2 pertains to Baripada workmen
 - e. Annexure 3 pertains to workmen of Head Office/Branch
3. The debts or dues of the workmen is unsecured.
4. Amount claimed by workers/workers’ representatives in respect of NRETF contributions has not been admitted as a claim, as the said amount, deducted from wages/salaries has been appropriated towards issue of equity shares of the Company.
5. Further the workmen of the Corporate Debtors have also claimed the termination benefit as provided under the Industrial Disputes Act, on account of their discharge that arises by virtue of the Liquidation Order, for which the Liquidator has filed an application for determination of the relevant question of law. The admitted claims do not include the termination benefit.
